**ORDINANCE No. 04-2015**  
**ORDINANCE REGULATING ANCLAM PARK**

The Town Board of Supervisors of the Town of Baileys Harbor ("Town Board"), Door County, Wisconsin, does ordain as follows:

**1. AUTHORITY.**

This ordinance is adopted pursuant to the authority granted under Wis. Stats. §60.22 (3) and 61.34 to enact ordinances and regulations promoting and protecting the health, safety, welfare, and convenience of the public, and defining and prohibiting public nuisances.

**2. PURPOSE.**

The purpose of this ordinance is to promote and protect the health, safety, welfare and convenience of the public in their use of parks in the Town of Baileys Harbor.

**3. PROHIBITED ACTIVITIES IN ANCLAM TOWN PARK.**

The following activities shall be prohibited in Anclam Park in the Town of Baileys Harbor, Door County, Wisconsin:

- A. No dogs are allowed on the beach or improved planted area within the park.
- B. All dogs in Anclam Park must be on a leash.
- C. There shall be no camping in Anclam Park.
- D. There shall be no diving from the floating dock or end of jetty of Anclam Park.
- E. No glass containers or objects shall be allowed on the beach within Anclam Park.
- F. Trailer parking shall be in designated trailer parking areas only.
- G. No vehicles over 20 feet long are allowed within Anclam Park.
- H. No person shall park any vehicle overnight in Anclam Park.
- I. The hours of operation of Anclam Park are 6 a.m. to 11 p.m. No person shall enter or remain upon Anclam Park outside of the hours of operation.

**4. PENALTIES.**

Any person violating any of the provisions of Section 3 shall be subject to a forfeiture of not less than \$50 nor more than \$200 for each violation. Each day that a violation exists shall be considered a separate violation. In addition, upon conviction, the person in violation shall be

subject to the imposition of court costs, expenses incurred by the Town, and actual and reasonable attorney fees incurred in prosecution.

**5. EFFECTIVE DATE.**

This ordinance shall be effective on the day following its passage and publication.
