All-terrain Vehicle and Utility-Terrain Vehicle Route
Town of Baileys Harbor, Door County, Wisconsin

An Amended Ordinance designating All-Terrain Vehicle and Utility-Terrain Vehicle Routes and regulating the operation of All-Terrain Vehicles and Utility-Terrain Vehicles in the Town of Baileys Harbor, Door County, Wisconsin

The Town Board of Supervisors of the Town of Baileys Harbor, Door County, Wisconsin, do ordain as follows:

1. **Authority.** This designation of all-terrain and utility terrain vehicle routes is created pursuant to authority provided to the Town of Baileys Harbor under section 1.1.01 as authorized by Wis. Stats, Section 23.33 (8) (b).
2. **Intent.** The Town of Baileys Harbor, Door County, Wisconsin, adopts the following all-terrain and utility-terrain vehicle route for the operation of all-terrain and utility-terrain vehicles upon the roadways listed in Exhibit A located within the Town of Baileys Harbor, Door County, Wisconsin.
3. **Routes.** The routes as designated on Exhibit A attached hereto and incorporated herein by reference are designated as all-terrain and utility-terrain vehicle routes in the Town of Baileys Harbor, Door County, Wisconsin.

Town of Baileys Harbor Ordinance #2018-02 is amended and recreated as follows:

4. **Requirements and Conditions.** As a condition for the use of any all-terrain and utility-terrain vehicle route in the Town of Baileys Harbor, the following requirements and conditions shall apply to all operators and passengers:
 - A. The applicable provisions of Wis. Stats. Section 23.33 regulating ATV/UTV operations are adopted.
 - B. All ATV/UTV operators shall be licensed drivers with a current valid driver's license.
 - C. All ATV/UTV operators shall operate at the lesser of 30 miles per hour or the posted speed limit.
 - D. All ATV/UTV operators shall ride single file.
 - E. Routes must be signed in accordance with NR 64.12 and NR 64.12 (7) (c).
 - F. All operators and or passengers age 16 and under must wear a helmet at all times the vehicle is in operation.
 - G. All operators must only ride on the designated routes; no operators shall ride on non-designated roads to reach designated riding roads. If operator does not have access to designated ATV/UTV route operators must trailer ATV/UTV vehicles to designated roads.

- H. If operator has registered their ATV/UTV with the DOT, they are exempt from this ordinance and will refer to the rules and regulations designed by the DOT
5. **Enforcement.** This ordinance shall be enforced by any law enforcement officer authorized to enforce laws of the State of Wisconsin.
 6. **Penalties.** Wisconsin state all-terrain vehicle penalties as found in Section 23.33 (13) (a), Wis. Stats. , are adopted by reference.
 7. **Severability.** The provision of this ordinance shall be deemed severable and it is expressly declared that the Town would have passed the other provisions of this ordinance irrespective of whether or not one or more provisions may be declared invalid. If any provision of this ordinance or the application to any person or circumstances is held invalid, the remainder of the ordinance and the application of such provisions to the other person's circumstance shall not be deemed affected.
 8. **Effective Date.** This ordinance shall be effective upon passage and the day following its publication.
